## **By road**

### **From Sevenoaks**

Follow the A25 east, turning right onto the A20 at the traffic lights at Wrotham Heath. At West Malling turn south on the A228 to Kings Hill. At the first roundabout, take the first exit right into Tower View and follow the map below.

### **From Tonbridge and Tunbridge Wells**

Take the A228 northbound, joining either via the A26 from Tonbridge or from the A21 at Pembury. Turn right into Gibson Drive at the first Kings Hill roundabout and follow the map below.

### **From Maidstone, Folkestone and Ashford**

Go west on the M20 to junction 4. Travel south on the A228 to Kings Hill. At the first roundabout, take the first exit right into Tower View and follow the map below. Alternatively from Maidstone, follow the A20 west and at West Malling turn south on the A228 to Kings Hill. At the first roundabout, take the first exit right into Tower View and follow the map below.

### **From North and East Kent**

From junction 2 of the M2, travel south on the A228 to Kings Hill. Turn into Tower View and follow the map below.

### **From London, the M25 and further afield**

M25 clockwise: Travel the M25 clockwise to junction 3. Go east on the M20 to junction 4. Leave the M20 and go south on the A228 to Kings Hill. Turn into Tower View and follow the map below.

## **M25 anticlockwise**

Take the M25 anticlockwise to junction 5. Take the M26 to junction 3 of the M20. Travel east to junction 4 of the M20. Leave the M20, going south on the A228 to Kings Hill. At the first roundabout, take the first exit right into Tower View and follow the map below.

## **Parking**

There is ample parking space available for visitors immediately outside the office.

## **By rail**

We are a 5 minute taxi ride from West Malling BR, a 25 minute taxi ride from Maidstone East BR and a 35 minute taxi ride from Tonbridge BR station.
